Sub: Reopening of Sea Borders with Qatar

To: All Ship-Owners, Managers, Masters and Shipping Agents

Please find attached UAE Maritime Administration Circular No.(01) of 2021 dated 8th Jan 2021.

As per above Circular, the United Arab Emirates has decided to end all measures taken against Qatar and to reopen its Airspace, Land and Sea borders with Qatar. Accordingly, any previous circulars issued by the UAE Maritime Administration relating to any restrictions on dealing with the State of Qatar, shall be abolished and maritime activities and movements between the two countries shall resume in their natural form starting from 00:00h 09/01/2021.

This notice also cancels NtM 10/2017 dated 7th Jun 2017 and any previous circulars issued by RAK Ports related to any restrictions on dealing with the State of Qatar with immediate effect.
